ANDRII DANYLENKO is an associate professor of Russian and Slavic linguistics at Pace University (New York). He was a foreign visiting fellow at SRC (2009-2010). He is the author of several books. He is the co-editor of *Studien zu Sprache, Literatur und Kultur bei den Slaven: Gedenkschrift für George Y. Shevelov* (Otto Sagner Verlag, 2012). His main areas of expertise are Ukrainian linguistics, linguistic typology, Slavic comparative grammar, and sociolinguistics, among others. He is currently working (together with Dr. Motoki Nomachi) on a new book-length project, "Slavic in the Language Map of Europe" (*Trends in Linguistics*, De Mouton Gruyter).

GENNADII ISAEV is a doctor of philology, professor, and head of the Department of Literature at Astrakhan State University. His sphere of scientific interest comprises the poetics of Russian literature of the twentieth century from the viewpoint of dialogue with cultures of the Muslim East, issues of the theory and methodology of literature, and literary regional studies. He is the author of twelve books and more than 180 articles, which include *Код исламской культуры в творчестве русских писателей* (Astrakhan, 2009), *Рецепция традиций исламской культуры в творчестве русских писателей* (Saarbrücken, 2012), and *Исламский Восток в творчестве русских писателей Серебряного века* (Astrakhan, 2013). He is currently engaged in studying the poetry of the Russian imagists.

BAKHIIYOR ISLAMOV is a professor of economics at the Tashkent Branch of Plekhanov Russian University of Economics. He was a foreign visiting fellow at SRC (2013-2014). His research interests include problems of systemic transformation. He has published a series of journal articles, chapters of books, papers, and the monograph *The Central Asian States Ten Years After: How to Overcome Traps of Development, Transformation and Globalisation* (Tokyo: Maruzen, 2001). The most recent paper on neo-liberal concepts and practice of systemic transformation has been printed as a chapter in the collective monograph *Новые тенденции в экономической науке и образовании* (Tashkent Branch of REU, 2014).

DONIYOR ISLAMOV is a postgraduate student at Moscow State Institute of International Relations (MGIMO). His research interests include economic problems of oil in Russia and Central Asian states. He has published a number of papers and articles in collective monographs such as "О влиянии цены на нефть на российский фондовый рынок: выводы для Узбекистана," *Стратегия дальнейшего повышения конкурентоспособности национальной экономики* (Tashkent: Bactria Press, 2012) and "World Oil Prices and Economic Reforms in Russia," *Макроэкономическая стабильность и комплексное социально-экономическое развитие* (Tashkent, Bactria Press, 2013).

TOMASZ KAMUSELLA is a reader of modern history at the Centre for Transnational History, School of History, University of St Andrews, St Andrews, Scotland, UK. ZHANAT KUNDAKBAYEVA, professor at the al-Farabi Kazakh National University, specializes in the history of imperial Russia.
